

Welcome to our December Derby auction catalogue

It's our final auction of 2018 at Pride Park Stadium in Derby and with 43 residential and commercial lots filling the pages of the catalogue, we're expecting another busy day.

Lots going under the hammer include buy-to-let opportunities suitable for landlords, renovation and development projects, properties ideal for family homes and first time buyers and a selection of commercial properties, plots of land and garages.

25 Tower Road in Hartsthorne (LOT 37) is a three bedroomed detached property occupying a cul-de-sac location with far reaching countryside views, offering the potential to extend subject to obtaining relevant planning permission. It comes with a *guide price of £165,000+ (plus fees).

A star lot in the auction comes at 10 Derby Road in Belper (LOT 9). A unique and rare opportunity to acquire an attractive stone built two bedroomed Grade II listed property. With a guide price of £90,000+ (plus fees) the property requires a scheme of improvement works throughout.

- 2. - 2A. - Q. What is a reserve price?
 A. A reserve price is the price stipulated as the lowest acceptable by the vendor. This figure is confidential between the vendor and auctioneer.
- Q. Is the guide price the same as the reserve price?
 A. No, not always. The guide is an indication given by the Auctioneer. Where the guide price is a bracket figure, the reserve cannot exceed the top end of the bracket price. If the guide price is a single figure, then the reserve can be up to 10% in excess of this.

Graham founded Graham Penny Auctions (now SDL Auctions Graham Penny) in 2006 and today, in semi-retirement, is still working with the business as a consultant.



What is your business motto?

Honesty, integrity and professionalism. It's about giving truthful help and advice in a friendly way; not necessarily telling someone what they want to hear, and being prepared to walk away from a job if you know you can't deliver the right result.

What is office like for you and your team?

As a consultant I am no longer in the office on a day-to-day basis, and in some senses I miss it, because we have a terrific team of capable friendly staff who are a delight to be with! It is a well-oiled machine with considerable expertise, a lovely atmosphere, efficiency and loads of hard work.

What is your approach to work / life balance?

I have always tried to keep a balance between work and play. Whilst you never switch your mind off - and constantly remind yourself of things still to do - there has to be some preplanned downtime, and space for other (important) things. After all, 'all work and no play makes Jack a dull boy' let alone risk the possibility of burn-out.

What is your approach to making contacts which are useful for the business?

Since I'm now a consultant I don't go out of my way to 'network' any longer but I'm always on the lookout for business opportunities. Occasionally they come without looking for them and it's still rewarding to get phone calls from people who say

something like - 'you sold a property for a friend of mine who was impressed with your services, so I hope you don't mind me contacting you.....' Recommendations are still encouraging!

Who has inspired you most in your business life, and why?

There have been several people who have taught me a lot in terms of business, but the person who stands out most and almost inevitably is the partner in W.S. Bagshaw and Sons to whom I was articled for three years as an 18 year old school leaver. He taught me so much – including 'Graham, don't be a clock watcher'! I still hate being late for appointments!

What is your proudest achievement in business?

There have been many proud moments in my working life, including winning several awards, but the real red letter day was selling Alton Manor in mid-Derbyshire in a marquee on the premises for £2.425m - the most expensive property I ever had the privilege to sell at auction. As an alternative, there was the excitement of setting up my own business - but that's another story!

What drives and motivates you?

There is a distinct caring attitude to my personality, so it would be to do a good job, help people and succeed in what they have asked you to do.

If you hadn't been an auctioneer, what would you do instead?

That's a difficult one! There's a lot of things I might like to be but do not have the aptitude or expertise. I think it might be something to do with estate or land management.

What time of day are you at your best, and why?

I'm definitely a morning person. I have no idea why that should be; some people are at their best late into the evening. I guess we're all different.

I do not use any type of social media. Maybe it's a generational thing, but generally I reckon I've got enough to do without spending another hour or two of my day with the phone. I'll stick with emails and WhatsApp!

There are many people I have admired, some of whom are no longer with us, but in my younger years I was very keen on cricket. So if you could organise for me to have a coffee with Sir Garfield Sobers (otherwise known as Gary) that would be brilliant!

How do you relax outside of work?

Outside of work I have all sorts of interests, some of which are not very relaxing! I do a lot of work with the church I belong to, I find gardening therapeutic, go on walks with my wife, visits or cycle rides, I enjoy holidays and seeing new places.
